



**Super 600® Corrugated Panels**

**Twenty Year Limited Warranty**

Sequentia Corrugated Super 600 panels are warranted by Crane Composites, Inc., 23525 W Eames, Channahon, IL 60410. This Warranty is extended to any original purchase from an authorized retailer.

The panels are warranted for twenty years to not rot, corrode, mold, mildew or develop structural cracks when kept reasonably clean through semi-annual washing to remove accumulated dirt.

The warranty is that for twenty years from the original retail purchase, Crane Composites, Inc. will provide, upon verification of failure, prorated reimbursement to the original purchaser for the cost of the panels. The owner is responsible for the cost of fabrication, labor and installation.

A pro rata depreciation charge (based on twenty years—each year is -5%) will be applied to the original purchase price of the panels.

The warranty applies only to panels stored, installed, and used in accordance with manufacturer’s recommendations and with recognized standards of construction. It does not apply to any failure or damage due to fire, lightning, hail, wind, unusual stresses, load weights or other conditions beyond the control of Crane Composites, Inc.

To present a claim under this warranty, a purchaser must remove the product label at time of installation and retain it with the original receipt of purchase and this warranty. Any claim must be made in writing and must be received by Crane Composites, Inc. within twenty years after the original retail purchase. It must describe and provide proof of the claimed defect or performance failure and must be submitted with the label, original receipt of purchase and this warranty to Crane composites, Inc. at the address below.

Crane Composites, Inc. will act to fulfill this warranty within 60 days after receiving a claim with all information necessary to determine its validity. This limited warranty is the sole warranty provided with Sequentia Corrugated Super 600 panels.

Crane Composites, Inc. options as stated above are the sole, exclusive remedy available to the owner. Crane Composites, Inc. shall not be liable for any incidental or consequential damages, including any damage to persons or property whatsoever, nor for breach of any express or implied warranty, nor for any implied warranty of merchantability or fitness for a particular purpose.
