## 4. First aid measures

## 5. Fire-fighting measures

## 6. Accidental release measures

## 7. Handling and storage

**Handling** : Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapor or mist. ## 8 . Exposure controls/personal protection

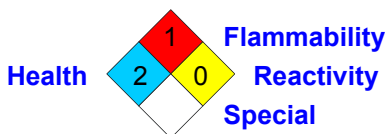
